## RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

In consideration of participating in the First State Gymnastics Program, I represent that I understand the nature of this activity that I am qualified, in good health, and in proper physical condition to participate in such activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the activity. I fully understand that this activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to be or not readily foreseeable at this time: and I fully accept and assume all such risks and all responsibility for losses, cost, and damage I incur as a result of my participation in the activity.

I hereby release, discharge, and covenant not to sue First State Gymnastics, its respective administrators, directors, coaches, volunteers, and employees, other participants, sponsors, advertisers, and owners and lessors of premises on which the activity takes place, (each considered one of the "Releasees" herein) from all liability, claims, demands, losses or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf makes a claim against any of the Releasees, I will indemnify, save, or hold harmless each of the releasees from any loss liability, damage, or cost, which any may incur as the result of such claim.
